Course outline

Course overview

The Certificate IV in Life Insurance is for people who already work or want to work in the life insurance industry. The Underwriting stream has been developed for underwriting job roles. This stream includes an introduction to legislation, life insurance products and services, claims and the skills to work well with clients. The Underwriting stream focuses on risk, underwriting complex medical risk, underwriting complex non-medical risks and the use of specialist terminology.

Learning outcomes

On successful completion of the **Underwriting stream subject**, students should be able to:

- Apply legislation, regulation and procedures to a life underwriting job role.
- Identify life insurance products and services and who they are suitable for.
- Understand the concepts of life risk and underwriting.
- Respond to client enquiries with client relationship management skills.
- Present a positive perception and adapt to a diversity of clients.
- Use client feedback to participate in continuous improvement processes.
- Understand the dispute resolution process and complaint management skills.
- Explain the process of underwriting complex medical risks.
- Understand the process of underwriting complex non-medical risks.
- Describe the concepts of claims assessment and its relationship to underwriting.
- Seek assistance with complex specialist and medical terminology as needed.

Course duration

Individuals who enrol into the FNS41515 Certificate IV in Life Insurance will have a total of 26 weeks to complete the qualification from their initial enrolment date.

The course has hardcopy notes and is delivered online. An additional four (4) weeks for the course is available if required to resubmit an assignment or resit an exam.

Delivery mode

This subject is delivered online.

Kaplan's online learning portal KapLearn enables the provision of innovative, interactive learning resources and support. KapLearn can be accessed anywhere at any time using a computer or mobile device that has internet access. Students are also provided with hard copy subject notes for their reference.

KapLearn is the access point for subject notes, supplementary learning material, practice activities and assessments. KapLearn is also the access point for ongoing support. The 'Ask your tutor' forum provides continuous technical support from subject matter experts.

Students may attempt the exam and/or submit their assignment at any time if they believe they are adequately prepared. Students will receive personal reminder emails as they approach their assessment deadlines.

Exemptions

Students may be able to obtain an exemption for a Kaplan award subject based on their previous study and/or work experience. To do this they must submit evidence that demonstrates they have already met the requirements of the subject through these other means.

Evidence can take many forms, such as information about approved study, information about work experience, certificates, transcripts or other credentials.
