Subject overview

Tier 1 Generic Knowledge provides the generic knowledge component for Tier 1 training and assessment requirements for existing advisers who provide general or personal financial advice to retail clients.

The subject introduces existing advisers to the participants, products, markets and regulatory environment for the financial services industry in Australia.

Existing advisers may need to meet additional regulatory or licensee requirements before providing specific advice in any knowledge area.

Learning outcomes

On successful completion of Tier 1 Generic Knowledge, existing advisers should be able to:

- Demonstrate their knowledge of the Australian financial services industry and the relevant legislation that applies to the provision of financial product advice
- Demonstrate their knowledge of the Australian economy and financial markets and their effects on investment issues and risk management
- Identify risks, and the appropriate insurance required to protect clients against those risks

Subject entry requirements

Subject duration

Existing advisers have a total of twelve (12) weeks to complete the learning and assessment requirements for Generic Knowledge from their initial enrolment date. An additional four (4) weeks resubmission time will be granted if the exam has been attempted and the existing adviser has been deemed not yet competent. This time can be used to re-sit the exam



Delivery mode

This subject is delivered online.

Students may attempt the exam and/or submit their assignment at any time if they believe they are adequately prepared. Students will receive personal reminder emails as they approach their assessment deadlines.

Recognition of Prior Learning

Individuals may be able to obtain Recognition of Prior Learning (RPL) for a Kaplan award subject based on their previous study and/or work experience. To do this, individuals must submit evidence that demonstrates they have already met the requirements of the subject through these other means.

Evidence can take many forms, such as information about approved study, information about work experience, certificates, transcripts or other credentials.
