



**Tier 1 Managed Investments —
General Advice**

Subject outline

Subject overview

Tier 1 Managed Investments introduces students to the concepts of managed investments as they apply to retail clients. The principles underpinning the foundation, structure, regulation and risks associated with the managed investment industry are also covered. Students will be shown how to analyse and evaluate managed investments, and will gain an understanding of the documentation and tax requirements when dealing with retail client portfolios.

Upon successful completion, individuals will meet the education requirements of ASIC Regulatory Guide 146 (RG146) for providing general advice in managed investments to retail clients, subject to their Licensee approval and until otherwise announced by ASIC.

Learning outcomes

Upon successful completion of Tier 1 Managed Investments — General Advice, students should be able to:

- Demonstrate their knowledge of the Australian financial services industry and the relevant legislation that applies to the provision of financial product advice.
- Demonstrate their knowledge of the Australian economy and financial markets and their effects on investment issues and risk management.
- Outline the characteristics and risks associated with managed investments.
- Demonstrate their knowledge of the regulation governing the product(s) and the taxation treatment of each.
- Analyse and evaluate products in relation to different client scenarios.
- Demonstrate technical compliance with RG 146 in managed investments.
- Provide general retail financial advice in managed investments and meet all compliance obligations for the provision of that advice.

Subject entry requirements

The prerequisite for this subject is Tier 1 Generic Knowledge.

Subject duration

Students have a total of 12 weeks to complete the learning and assessment requirements for Tier 1 Managed Investments — General Advice, from their initial enrolment date.

The subject does not include hard copy notes and is delivered online.

An additional four weeks (4) per subject is available if required to resit an exam.

Delivery mode

This subject is delivered online.
