## SUBJECT OVERVIEW

---

This subject is designed to offer specialised knowledge and skills to expand trading experience and advanced derivatives transactions in the Australian options market. The subject aims to provide students with a comprehensive understanding of the knowledge and skills required to provide advice on advanced derivatives transactions including:

- taking options
- writing options
- spreads
- straddles and strangles
- low exercise price options
- other ASX derivatives products and strategies as prescribed in the ASX's procedures.

## SUBJECT ENTRY REQUIREMENTS

---

ADA1 must be completed prior to enrolment into ADA2.

Individuals are required to be 18 years and over to enrol in this subject.

Individuals who are in Australia on a student visa are unable to enrol in this subject. If you are in Australia on a visa and wish to enrol, you need to check that you are enrolling in accordance with the study conditions of your visa.

## SUBJECT DURATION

---

Students have a total of 12 weeks to complete the assessment requirements for Accredited Derivatives Adviser Level 2 (ADA2).

An additional 4 weeks is available if students are required to resit their examination.

This subject will take students between 60 and 120 hours to complete, depending on their experience in the derivatives industry.

Students should expect to spend up to 10 hours a week reading their subject notes, completing the learning activities and preparing for the exam.

Students working in the industry may be able to complete this subject requirements in a shorter timeframe or less hours per week.

## DELIVERY MODE

---

This subject is delivered online and does **not** include hard copy notes.

## ASSESSMENT TASKS

---

The assessment task for this subject is:

**Examination:** Supervised, **closed book** online multiple choice exam.

A 138 minute supervised closed book exam of 55 multiple choice questions, based on the topics in the subject notes. All exam answers can be sourced from the subject notes. Readings and other supplementary materials are not assessable. Students will receive instant results at the completion of the exam.

Students must sit the exam within 12 weeks of their enrolment date.

The exam has six segments:

- Segment 1: Topic 1 and 2 (10 questions)
- Segment 2: Topic 3 (10 questions)
- Segment 3: Topic 4 (10 questions)
- Segment 4: Topic 5 (10 questions)
- Segment 5: Topic 6 (10 questions)
- Segment 6: Topic 7 (5 questions)

Students must achieve an 80% pass mark in each segment of the exam. If a student fails their examination, they will be re-examined only on the segment(s) for which they were deemed 'not yet competent'.

An enrolment entitles the student to up to two resit exams on any segments for which they are assessed as 'not yet competent'. Students must complete any resit exams within four (4) weeks of their first exam attempt.

Students may attempt the exam at any time if they believe they are adequately prepared. Students will receive personal reminder emails as they approach their assessment deadline.

Students who complete the subject will receive a Certificate of Completion.
