## PART 1: RECOGNITION OF PRIOR LEARNING INFORMATION

## What is Recognition of Prior Learning?

At Kaplan Professional, we recognise that you may be eligible for Recognition of Prior Learning as a result of your prior studies and industry experience. When you apply for Recognition of Prior Learning, we will assess your prior studies and experience, and you may be awarded advanced standing (also known as "credit") for a portion of the course in which you are currently studying. Recognition of Prior Learning may result in a reduction of the amount of study required to achieve your qualification.

## Recognition of Prior Learning for existing financial advisers

This Recognition of Prior Learning application form is for existing financial advisers seeking credit as part of the legislated *Corporations (Relevant Providers Degrees, Qualifications and Courses Standard)*Determination 2021 education pathway.

A person will demonstrate that they are an existing adviser if they:

- were listed on the financial advisers register as being authorised to provide personal advice at any time between 1 January 2016 and 1 January 2019 (either under the heading of 'Current appointment(s)' or 'Previous appointment(s)'); and
- were not banned, disqualified or subject to an enforceable undertaking (where they undertook to not provide financial product advice or financial services in any capacity) on 1 January 2019.

The <u>FPS001 Education Pathways Policy</u> provides the collective rules and expectations in relation to ensuring existing advisers complete the appropriate education. This includes four education pathways (applicable to existing advisers only):

- 1. the approved degree pathway
- 2. the relevant degree pathway
- 3. the non-relevant/other degree pathway
- 4. the no degree pathway.

In terms of Recognition of Prior Learning provided under the <u>FPS001 Education Pathways Policy</u>, Existing Advisers are eligible, dependent on the pathway, for credits via Recognition of Prior Learning.

This application form is to be used by existing advisers seeking Recognition of Prior Learning in accordance with these requirements.

## How to complete your application

Applicants must fully complete this application form and submit the completed application to <a href="mailto:rpl@kaplan.edu.au">rpl@kaplan.edu.au</a> ensuring they have:

- completed the application form and signed the declaration;
- supplied the required supporting evidence.

**Note:** Your application for Recognition of Prior Learning will not be reviewed until the completed application, signed declaration and required evidence have been provided.



## **Advanced Standing guidelines**

Advanced Standing is awarded in accordance with Kaplan Professional's <u>Recognition of Prior Learning Policy</u> and <u>FASEA Transition Policy</u>.

#### Important to note:

- Advanced Standing will be assessed and awarded towards Kaplan's Graduate Diploma of Financial Planning qualification or Master of Financial Planning qualification only.
- Students may obtain Advanced Standing up to a maximum of 50% of the total number of subjects in the Graduate Diploma of Financial Planning under this pathway.
- Students may obtain Advanced Standing up to a maximum of 50% of the first 8 subjects in the Master of Financial Planning course structure under this pathway.
- Kaplan Professional will not grant Advanced Standing for any subjects if the subject has been awarded Advanced Standing or credit previously at either Kaplan Professional or another provider.

## How long will the assessment of my application take?

Kaplan Professional will respond to your application within 15 calendar days. If insufficient supporting evidence is provided, your application may be delayed or declined.

## How will my application be assessed?

Kaplan Professional will undertake an academic review of your application based on your supporting evidence. Kaplan Professional may contact you if further details are required to review your application, which may result in a delay in the assessment of your application.

If your application is approved, Advanced Standing may be granted for the relevant subjects. If your application for Recognition of Prior Learning is declined, you will need to enrol into and complete the relevant subjects in order to complete your qualification.

## Can I appeal the outcome of any decision related to my application?

You may appeal the outcome of Kaplan Professional decision in accordance with the <u>Complaints and</u> Appeals policy located on our website.

- Diploma of Financial Advising (8 subjects) awarded by Securities Institute
- Diploma of Financial Markets (8 subjects) awarded by Securities Institute

#### Option 2: Recognition of Prior Learning based on an approved professional designation

Submit an application via this option if you have completed coursework in the process of attaining a legislated Professional Designation as published in the <u>Corporations (Relevant Providers Degrees, Qualifications and Courses Standard)</u>
<u>Determination 2021</u>.

#### Option 3: Recognition of Prior Learning based on prior study completed at an AQF 7, 8 (Graduate Diploma) or 9 level
